# Treatment Needs of Women & the Impact of Stigma

Additionally, the training will explore the barriers and stigma that negatively impact seeking, engaging, and remaining in treatment. Each participant will leave the training with a personalized plan of how they will support women entering treatment and combatting stigma they face.

It will then move into concepts of professionalism, including attitude, competence, appearance, responsibility, teamwork, communication, among others. It will focus on specific and concrete behaviors to engage in and not engage, it will finish on the importance of professional development and what to look for in quality trainings. Throughout the presentation there will be group discussion, group polis, and interactive activities to keep all participants fully engaged.

## Are We Helping or Hurting? Family Dynamics, Substance Misuse, Addiction & Recovery

William Stauffer, LSW, CCS, CADC

Substance misuse and addiction impacts the entire family constellation. How we think about and respond to substance use matters. It is as individualized as it is working with the member impacted by the use. In this training we will consider how we conceptualize SUD impacted family drynamics. We will explore family in the context of the SUD recovery movement, shame and negative perception about SUD as a barrier to seeking help. We will also consider the opportunities moving forward to incorporate family wellness into the spectrum of long-term care and support healing efforts for SUD in America.

#### Learning Objectives

- Identify subjective characteristics of "functional" & "dysfunctional" behavior and how homeostasis is disrupted when substance use, misuse, & addiction occurs in the family
  - Learn about selected history of family focus in the US recovery movement to contextualize our current era
  - Develop a deeper understanding on the impact of shame and stigma on family wellness and explore roles often assumed within substance misuse impacted families

# Biography

William Stauffer is the Executive Director of Pennsylvania Recovery Organization Alliance (PRO A). He is in long-term recovery since age 21 and has been actively engaged in public policy in the recovery arena for most of those years. Bill is a graduate of Northampton Community College, Cedar Crest College, and Kutztown University. He is also an adjunct professor of Social Work at Misericordia University in Dallas Pennsylvania, Bill has over 25 years of clinical and administrative experience in both inpatient and outpatient settings. He has been a staunch advocate for strong SUD Patient Privacy Protections at both the state and federal levels for many years and has initiated numerous workforce expansion initiatives for persons in recovery. A major focus of his work has been aimed at moving our entire SUD care system towards a five-year care paradigm to dramatically expand the numbers of Americans in Recovery while saving lives, resources, & communities. Bill was the 2019 recipient of the Vernon Johnson Award Individual Recovery Advocate of the year, and the 2002 Recipient of the Legie G. Machell prize in Social Work. Prior to taking the position of executive director of PRO-A, he was awarded the Recovery Advocate of the year in 2008.
